**Skin Contact:**

Wear approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust.

**Environmental Precautions:** In the event of a major spill, prevent spillage from entering drains or water courses.

**Methods and Materials for Containment and Cleaning Up:**

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation.

### 7 Handling and Storage

**Precautions for Safe Handling:**

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

**Conditions for Safe Storage:**

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Protect from heat, sparks, open flames and other sources of ignition. Keep away from oxidising agents, halogens, carbides, metals and ammonia. Store below 40 C.

## 8 Exposure Controls and Personal Protection
